The Anti-Corruption (Declaration of Gifts) Regulations, 2013

IN EXERCISE of the powers contained in section ninety-four of the Anti-Corruption Act, 2012, the following Regulations are hereby made:

These Regulations may be cited as the 1. Anti-Corruption (Declaration of Gifts) Regulations, 2013.

Interpretation

Title

Prohibition of offering or acceptance of gift

In these Regulations, unless the context 2. otherwise requires, "gift" includes a casual gift.

(1) A public officer shall not, without 3. the permission of the controlling officer or chief executive officer of the public body, accept any gift, reward, benefit or any other valuable present in any form, including free passage, hospitality or other favours, from any person or body that has an interest that may be affected by the public officer's official duties.

A public officer shall refuse any gift, (2)reward, benefit or any other valuable present in any form, including free passage, hospitality or other favours offered to the public officer or member of the public officer's family by any person or body that has or seeks dealings of any kind with the public

body in which that public officer is a member, employee or is otherwise engaged.

(3) A public officer shall not-

• (a) give a gift to a superior officer;

(b) make a contribution or solicit a contribution, for a gift to a superior officer; or

(c) solicit a contribution from another public officer for a gift to a superior office;

Declaration of gift

5. (1) A public officer shall, within fortyeight hours of receipt of any unsolicited gift declare that gift to the controlling officer, chief executive officer or officer in charge of the public body.

(2) A controlling officer, chief executive officer or officer in charge of a public body shall record the particulars of the gift, the source, the purpose and the date of the gift in the gift register.

(3) A declaration of gift by a public officer shall be made in Form I set out in the Schedule.

Register of Gifts

6. (1) A chief executive officer or head of department of a public body shall keep and maintain a register of gifts which shall be maintained by the controlling officer, chief executive officer or officer in charge of the public body, as the case may be.

(2) A Register of Gifts shall be in Form II set out in the Schedule.
